

At ThirtySevenCelsius.com.au, we collect and manage user data according to the following Privacy Policy, with the goal of incorporating our company values: transparency, accessibility, sanity, usability. This document is part of ThirtySeven Celsius's Term's and Conditions, and by using thirtysevencelsius.com.au (the "Website"), you agree to the terms of this Privacy Policy and the Terms and Conditions. Please read the Terms and Conditions in their entirety, and refer to those for definitions and contacts.

Data Collected

We collect anonymous data from every visitor of the Website to monitor traffic and fix bugs. For example, we collect information like web requests, the data sent in response to such requests, the Internet Protocol address, the browser type, the browser language, and a timestamp for the request.

We ask you to log in and provide certain personal information (such as your name and email address) in order to be able to save your profile and the documents and comments associated with it. In order to enable these or any other login based features, we use cookies to store session information for your convenience. You can block or delete cookies and still be able to use ThirtySevenCelsius.com.au. In order to take advantage of certain features of the Website, you may also choose to provide us with other personal information, such as your picture or personal website, but your decision to utilise these features and provide such data will always be voluntary.

Minors and children should not use ThirtySevenCelsius.com.au. By using the Website, you represent that you have the legal capacity to enter into a binding agreement.

Use of the Data

We only use your personal information to provide you the ThirtySevenCelsius.com.au services or to communicate with you about the services or the Website.

With respect to any documents you may choose to upload to ThirtySevenCelsius.com.au, we take the privacy and confidentiality of such documents seriously. We encrypt all documents, and permanently delete any redacted edits you make to documents. We employ industry standard techniques to protect against unauthorised access of data about you that we store, including personal information.

We do not share personal information you have provided to us without your consent, unless:

- we believe it's needed to detect, prevent, or address fraud, security, or technical issues;
- otherwise protect our property, legal rights, or that of others.

ThirtySevenCelsius.com.au is operated from Australia. If you are visiting the Website from outside Australia, you agree to any processing of any personal information you provide us according to this policy.

Only aggregated, anonymised data is periodically transmitted to external services to help us improve the ThirtySevenCelsius.com.au Website and service. We currently use Google Analytics (traffic analysis, SEO optimisation), and Mailchimp (mailing list management). We listed below what data these third parties extract exactly. Feel free to check out their own Privacy Policies to find out more.

- Google Analytics: anonymous (ad serving domains, browser type, demographics, language settings, page views, time/date), pseudonymous (IP address)
- Mailchimp: name and email of our beta subscription list

We also use social buttons provided by services like Twitter, Google+, LinkedIn and Facebook. Your use of these third party services is entirely optional. We are not responsible for the privacy policies and/or practices of these third party services, and you are responsible for reading and understanding those third party services' privacy policies.

We employ and contract with people and other entities that perform certain tasks on our behalf and who are under our control (our "Agents"). We may need to share personal information with our Agents in order to provide products or services to you. Unless we tell you differently, our Agents do not have any right to use Personal Information or other information we share with them beyond what is necessary to assist us. You hereby consent to our sharing of Personal Information with our Agents.
